- 6. The Agent undertakes to ensure that all the details of the prospective buyer will be recorded in the visitors' register. No prospective buyer will enter the Estate without positive identification.
- 7. The Agent undertakes not to allow more than one prospective buyer (and his family) to view the show house at any one time and must take them in his/her own car (not allow the vehicle of the prospective buyer into the Estate) to the show house/vacant stand.
- 8. The Agent undertakes to escort the prospective buyer (and his family) out of the Estate immediately after they have finished viewing the show house or vacant stand.
- 9. I understand that the Agency will lose its accreditation plus deposit paid, if any of the Rules and Regulations of the Waterkloof Boulevard has not been adhered to during the show of the house/stand.
